



## Recycling Education Outreach Internship

The North Central Ohio Solid Waste District (NCO) has a goal to reduce contamination levels and increase participation for the curbside recycling program in the City of Marysville. NCO is seeking to hire two interns to assist our staff with the following in 2019:

1. Educate residents on recycling, contamination rates, and acceptable materials.
2. Represent NCO at outreach events
3. Conduct the curbside recycling education initiative

**Internship Period:** Internship will commence on or about May 13 and end on or about August 2, 2019. The internship period will cover 12 weeks of work at 40 hours per week. The days of work will be Mondays for office work and Tuesday through Friday for field work. The field work day will begin at 5:00 am and ends at 1:30 pm with a 30-minute lunch break and the office day will be normal 8 am - 4:30 pm hours. 80% field, 20% office. Pay ranges from \$12.00 - \$15.00/hour.

### Primary Responsibilities:

- Evaluate curbside recycling carts for contamination.
- Tag cart with contaminate materials.
- Document and present findings and trends.
- Assist staff with ordering of tags and educational flyers
- Participate in various meetings

### Requirements:

- Must be 18 years of age by first day of Internship
- Valid Ohio driver's license
- Applicants must be physically able to perform field work such as but not limited to walking long distances.
- Be located in Union County, Champaign County, Hardin County, Shelby County, Madison County, Allen County, Franklin County, Allen County, or surrounding county in Ohio.
- Be enrolled or entering into a college degree program.
- Commit to working full-time for 12 weeks from mid-May to mid-August.
